Under the Telecommunications Act of 1996, The Healthcare Connect Fund Program was created by the FCC to help eligible Health Care Providers (HCPs) receive subsidies for eligible data and telecom related services for rural and urban facilities. Services can include circuits for internet, network communications, EMR, telemedicine and more.

Individual HCPs can apply as well as a consortium, i.e., a group of HCPs that can be both rural and non-rural. Eligible HCPs can receive a 65% discount on eligible broadband connectivity expenses.

The program is funded by the Universal Service Fund (USF) and is managed by the Universal Service Administrative Company (USAC).

THROUGH THE HCF PROGRAM, HCPs CAN RECEIVE FUNDING FOR:

- Current Services
- Upgraded Services
- Installation of New Services (Including Installation Costs)
- Network Equipment
- Network Maintenance Fees
- Network Consulting Services
